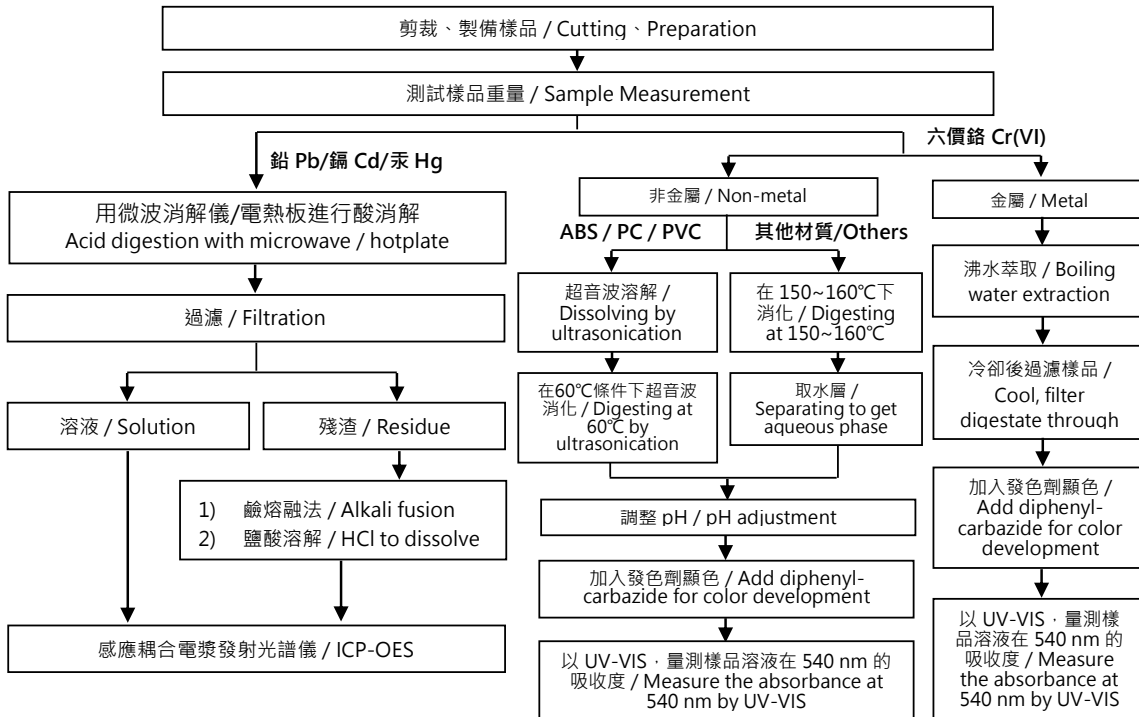

重金屬流程圖 / Analytical flow chart of Heavy Metal

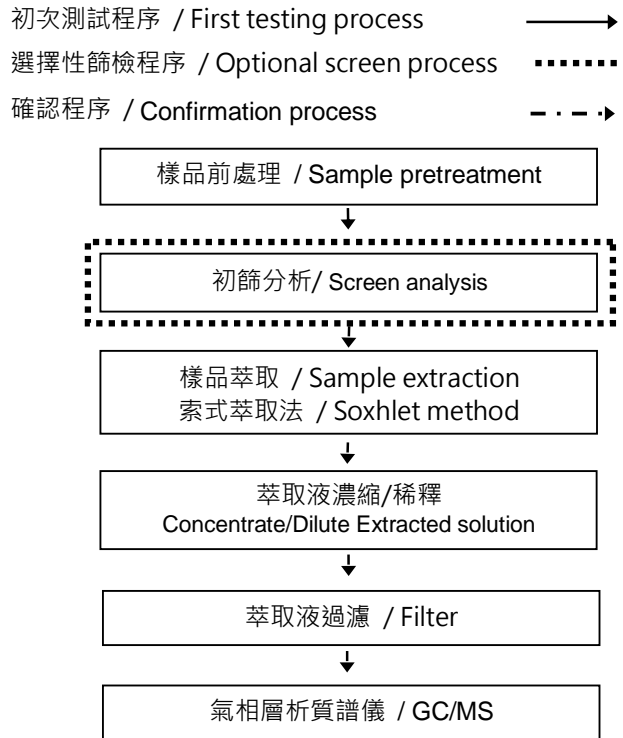

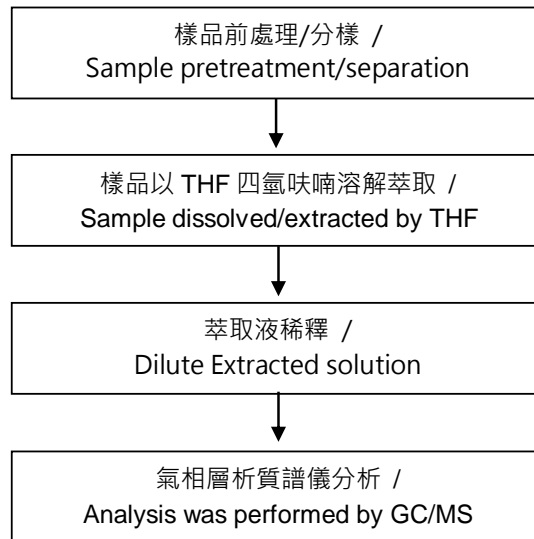
多溴聯苯/多溴聯苯醚分析流程圖 / Analytical flow chart - PBBs/PBDEs

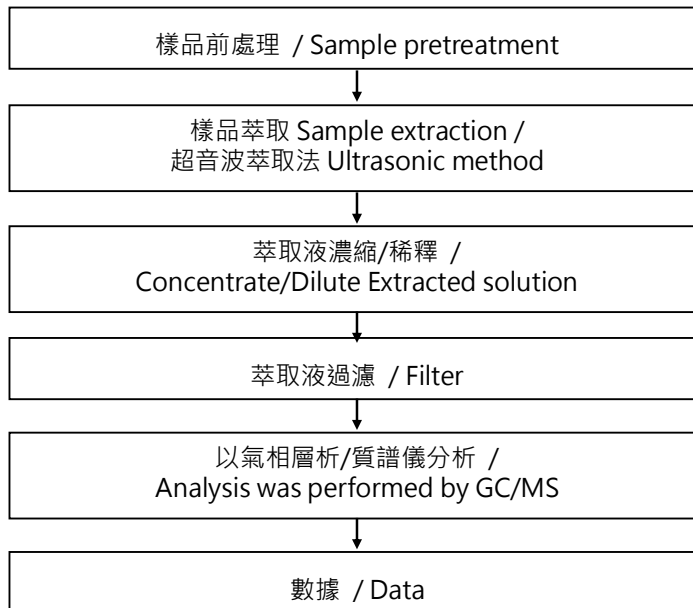
可塑劑分析流程圖 / Analytical flow chart - Phthalate

六溴環十二烷分析流程圖 / Analytical flow chart - HBCDD

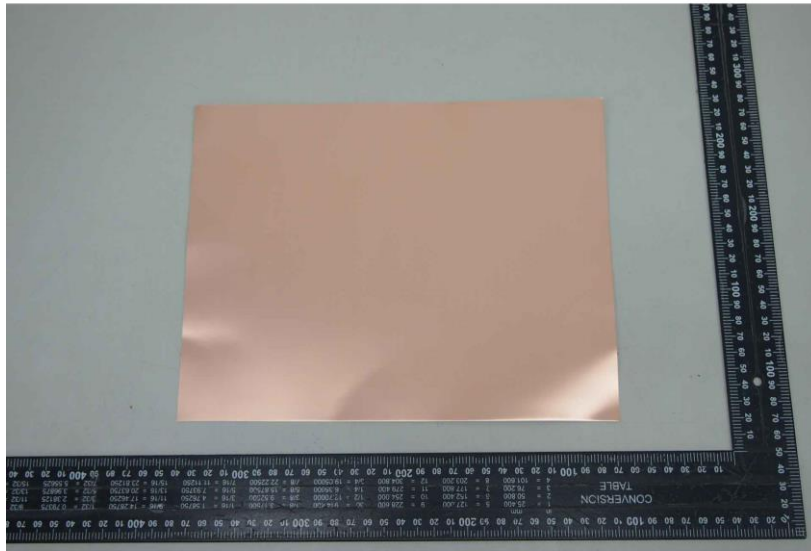
