

PFAS Remark:

The tested results of the analyzed specific structure cannot be distinguished to identify the contribution from PFAS acid or its salts. Therefore, the tested results display the sum of concentrations of PFAS acids and its salts with the same carbon number group. The concentration of PFAS substances in the below table have been included in the tested results, please refer to the table for relevant information: (The listed PFAS substances are examples only, it do not include all PFAS salts with the same carbon number group.))



鹵素分析流程圖 / Analytical flow chart - Halogen





雙酚A分析流程圖 / Analytical flow chart - Bisphenol A



有機錫分析流程圖 / Analytical flow chart - Organic-Tin






