

全氟辛酸/全氟辛烷磺酸分析流程圖 / Analytical flow chart - PFOA/PFOS



四溴雙酚-A 分析流程圖 / Analytical flow chart - TBBP-A



雙酚A分析流程圖 / Analytical flow chart - Bisphenol A



有機錫分析流程圖 / Analytical flow chart - Organic-Tin



聚氯乙烯物質判定分析流程圖 / Analysis flow chart - PVC








