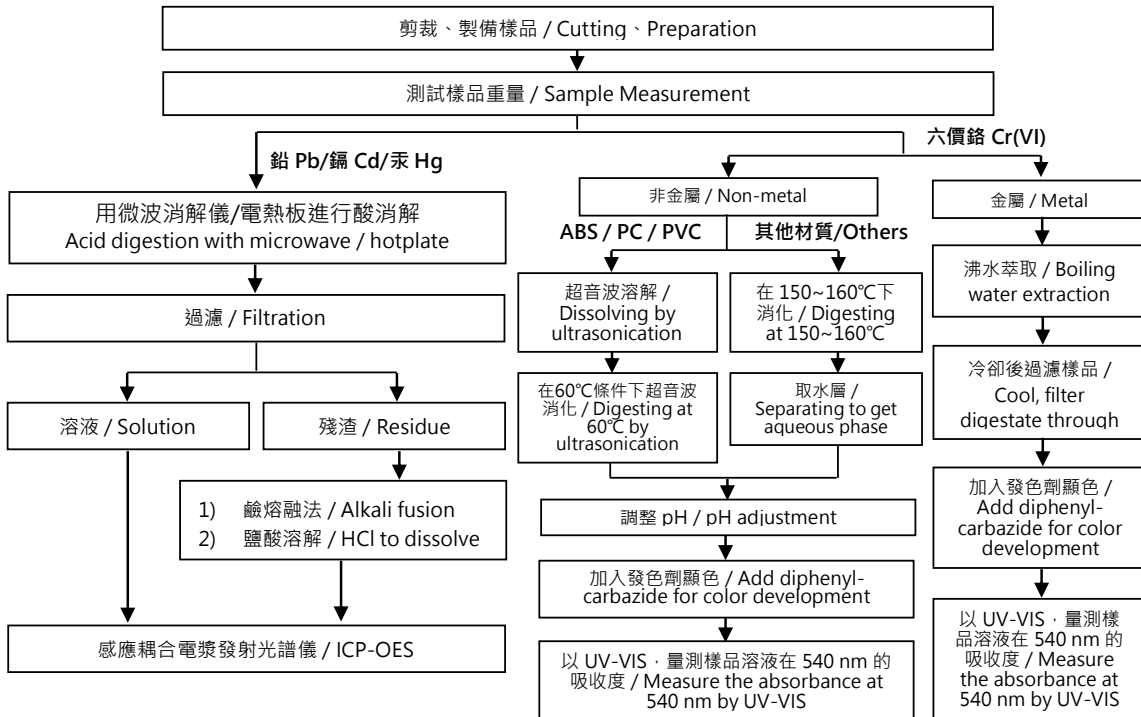

### 重金屬流程圖 / Analytical flow chart of Heavy Metal

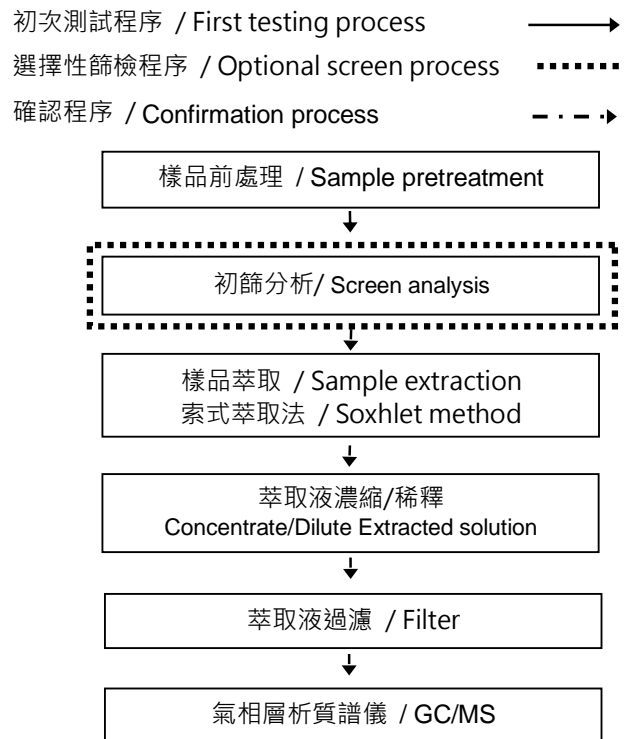

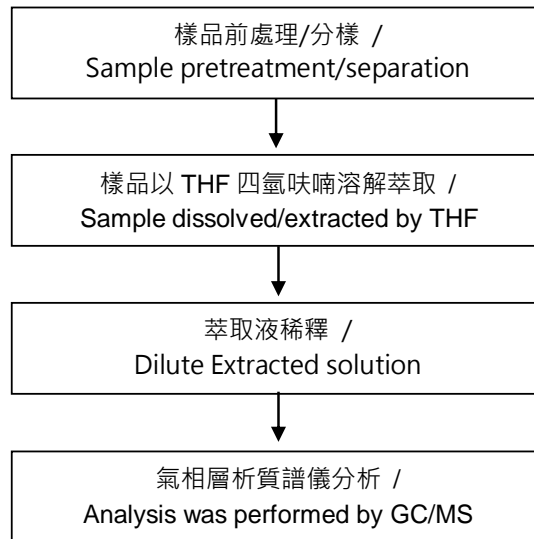
### 多溴聯苯/多溴聯苯醚分析流程圖 / Analytical flow chart - PBBs/PBDEs

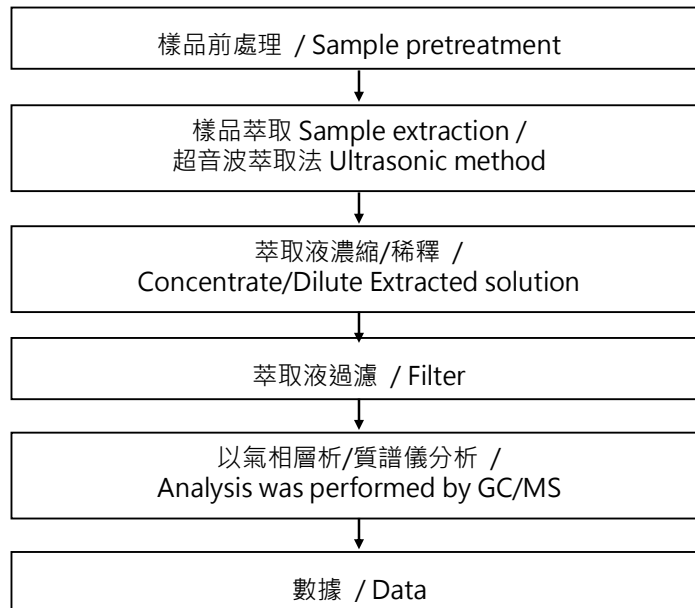
