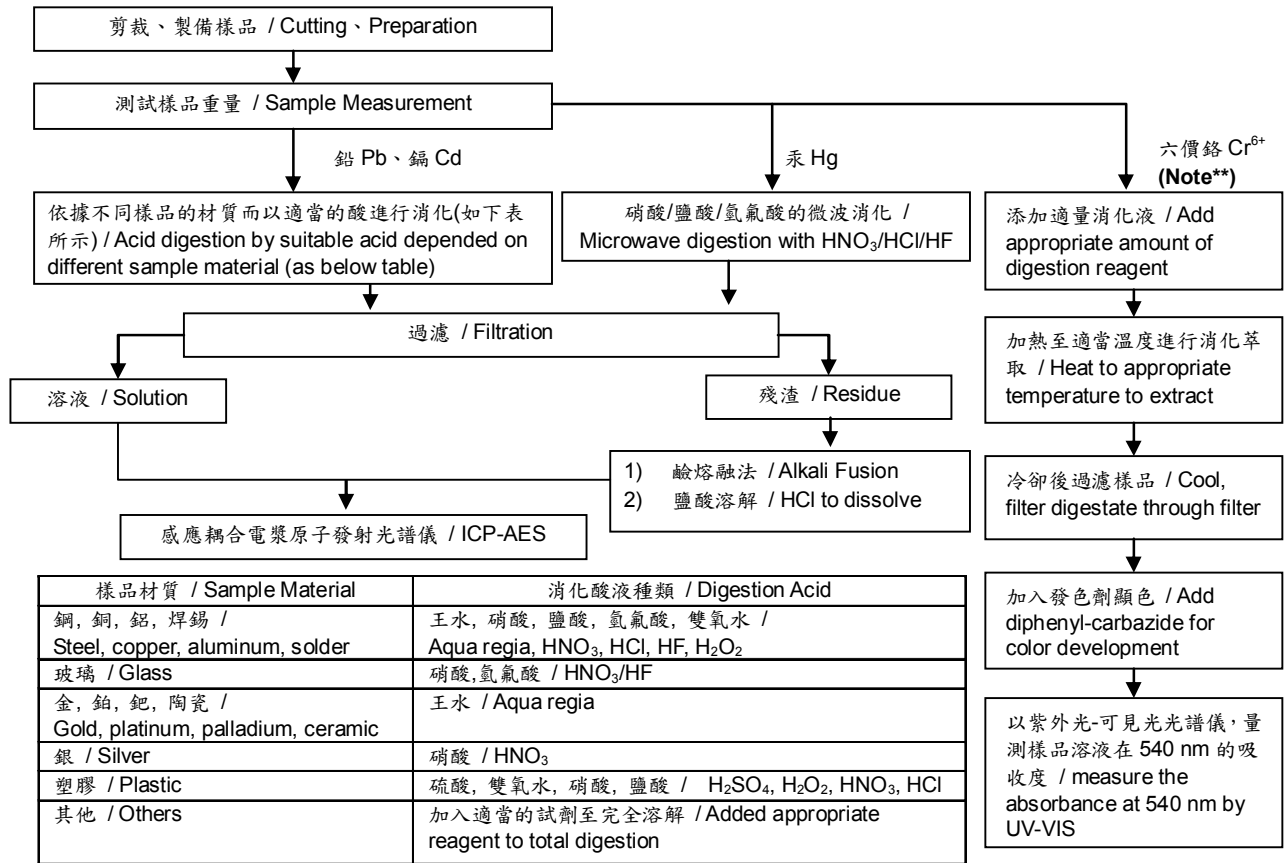

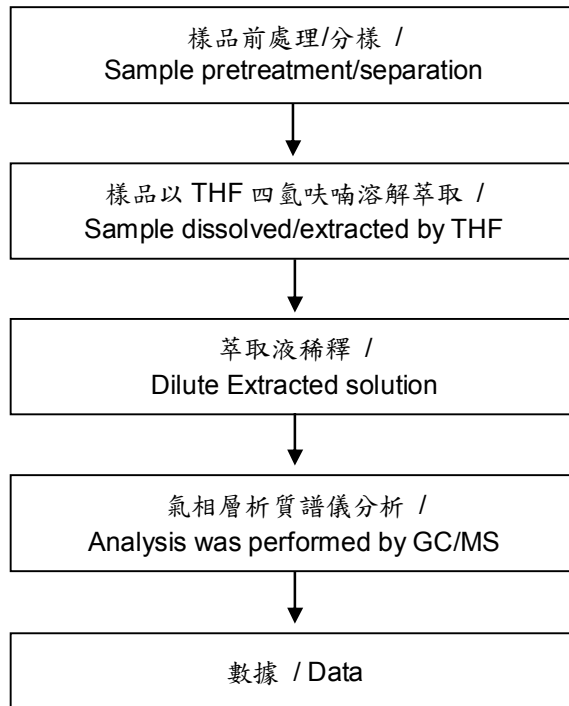

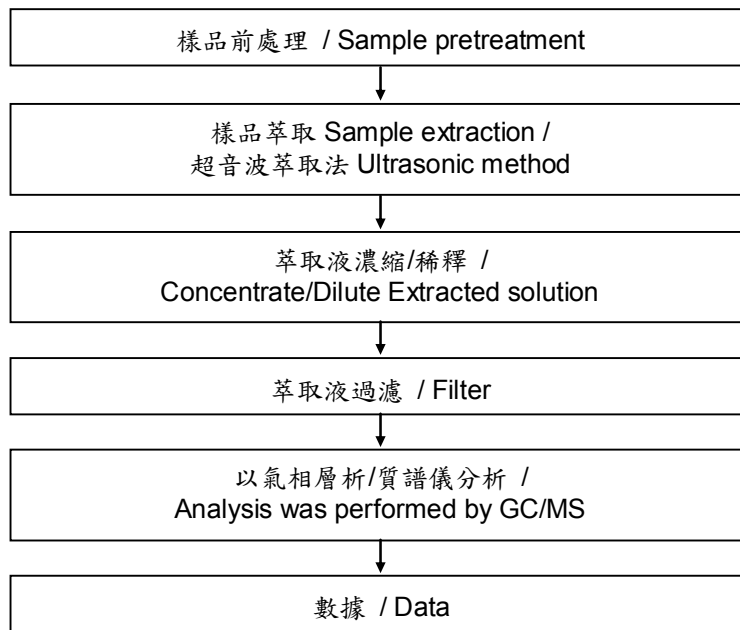

### 六溴環十二烷分析流程圖 / HBCDD analytical flow chart

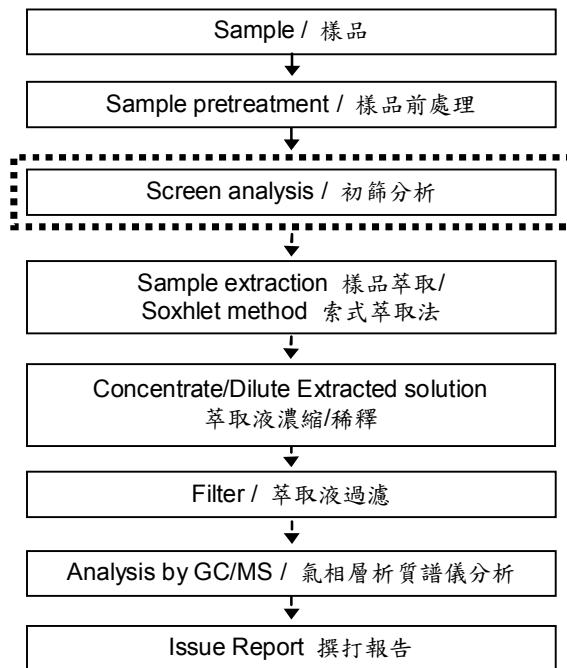
