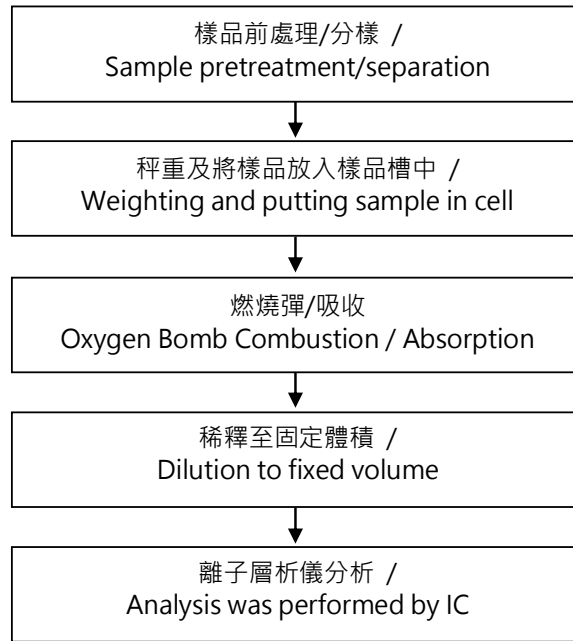

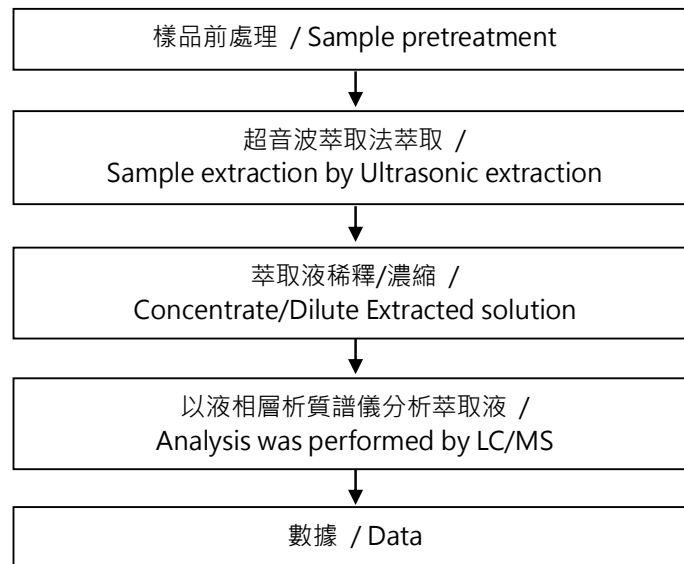

鹵素分析流程圖 / Analytical flow chart - Halogen



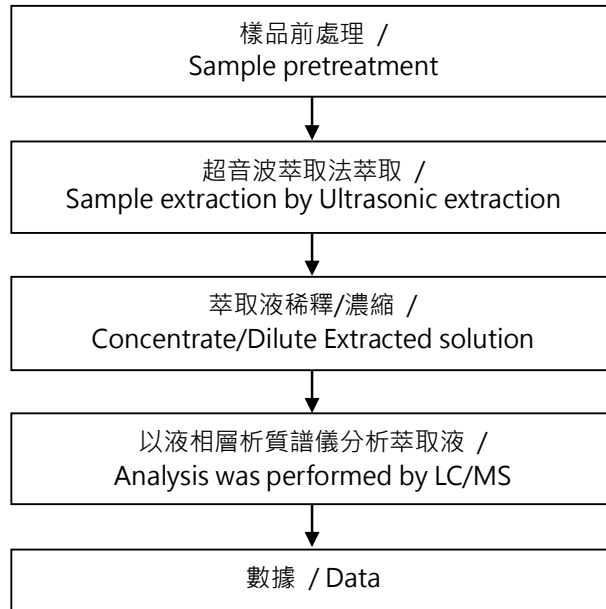

### 全氟辛酸/全氟辛烷磺酸分析流程圖 / Analytical flow chart - PFOA/PFOS



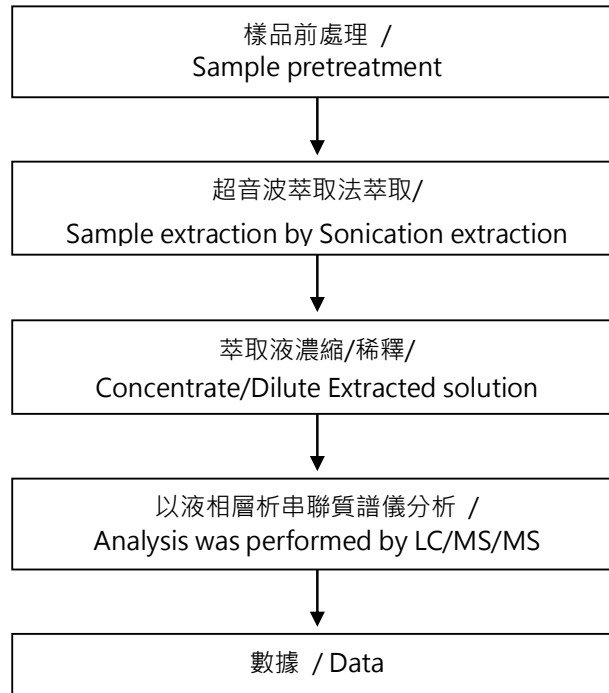

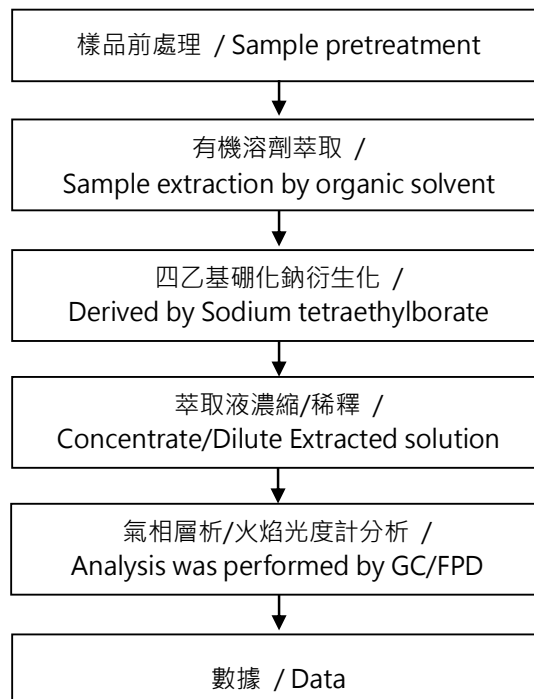
雙酚A分析流程圖 / Analytical flow chart - Bisphenol A

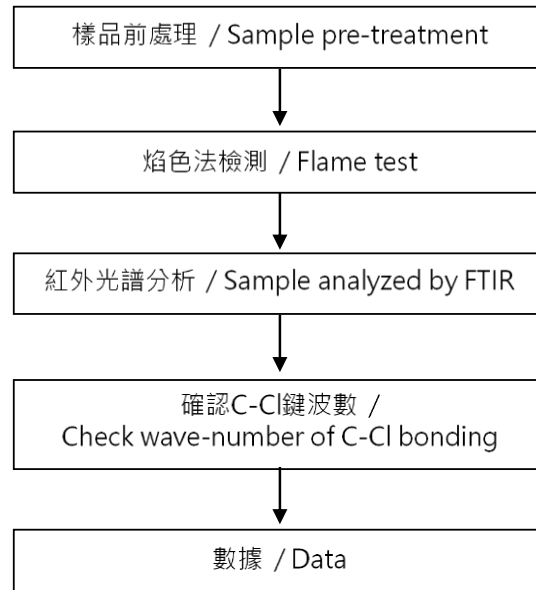


有機錫分析流程圖 / Analytical flow chart - Organic-Tin

### 聚氯乙烯物質判定分析流程圖 / Analysis flow chart - PVC



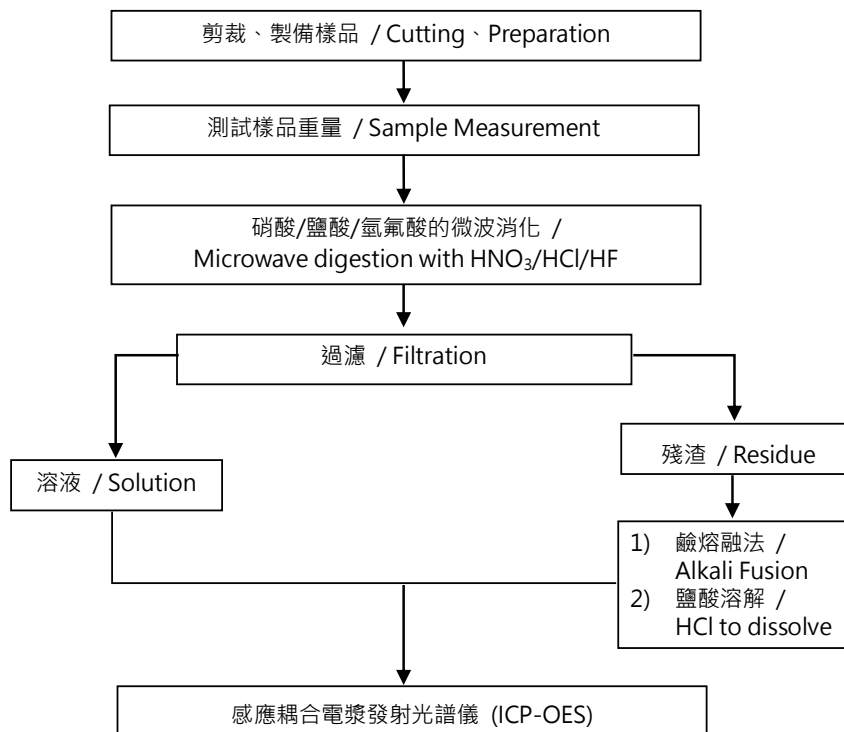
