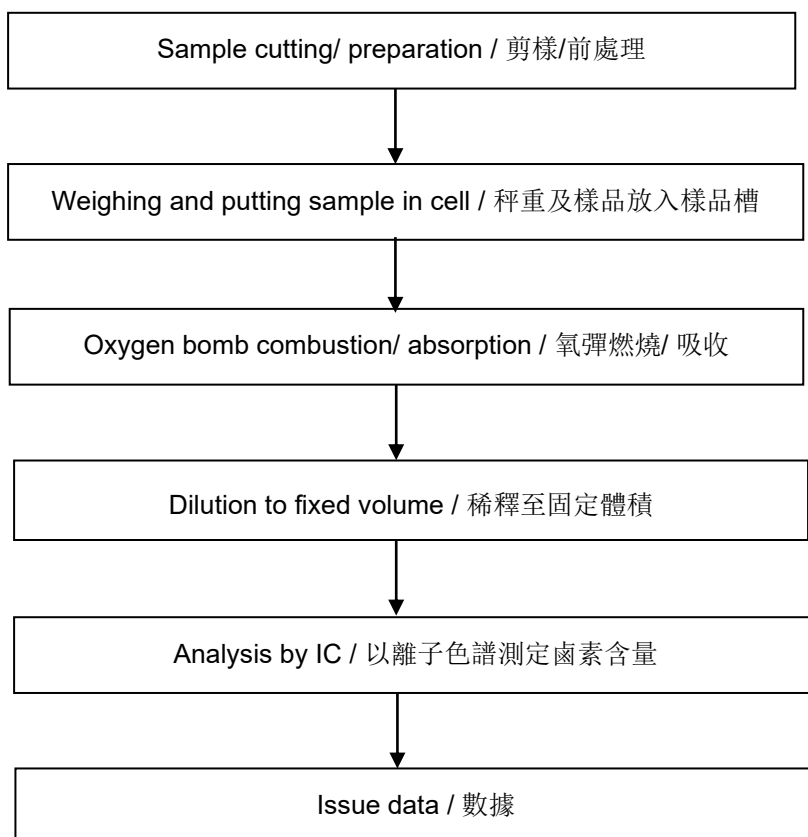

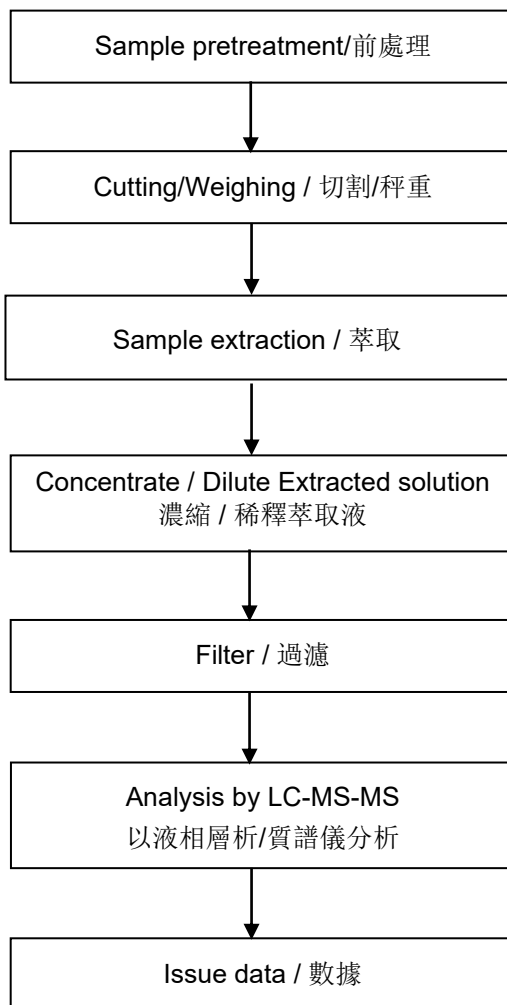

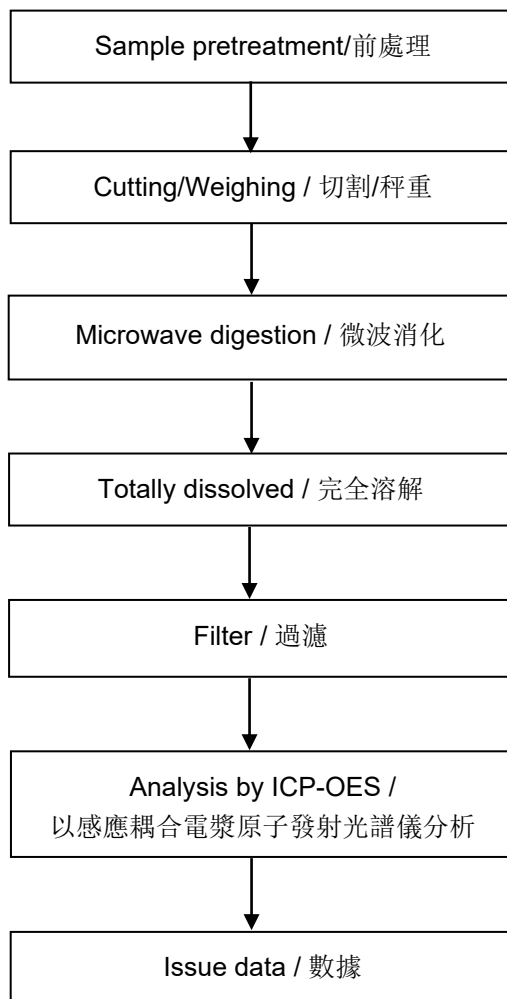
PFOS/全氟辛烷磺酸, PFOA/全氟辛酸; BPA/雙酚-A

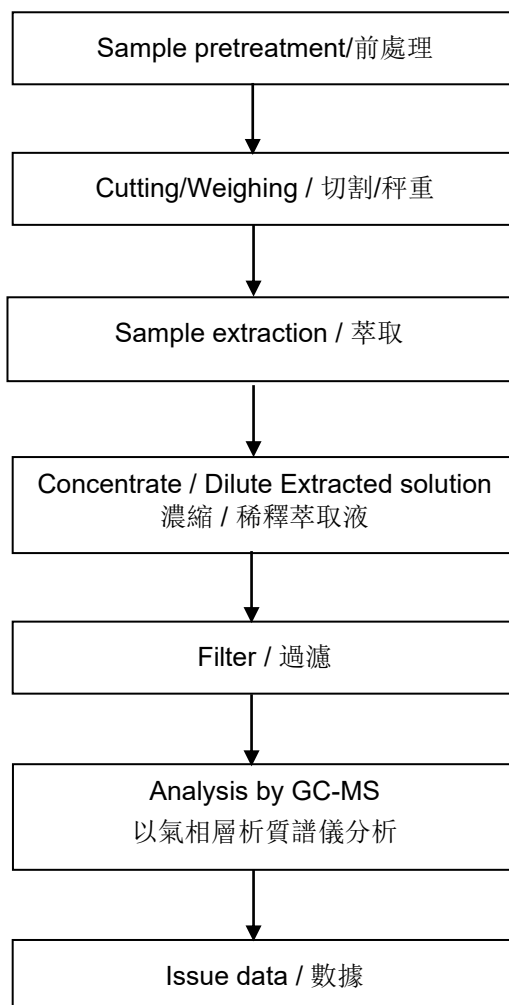

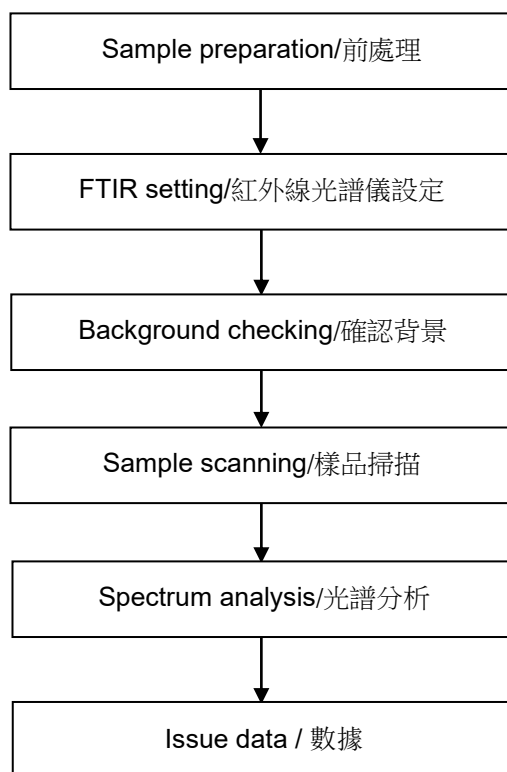

PVC/聚氯乙烯

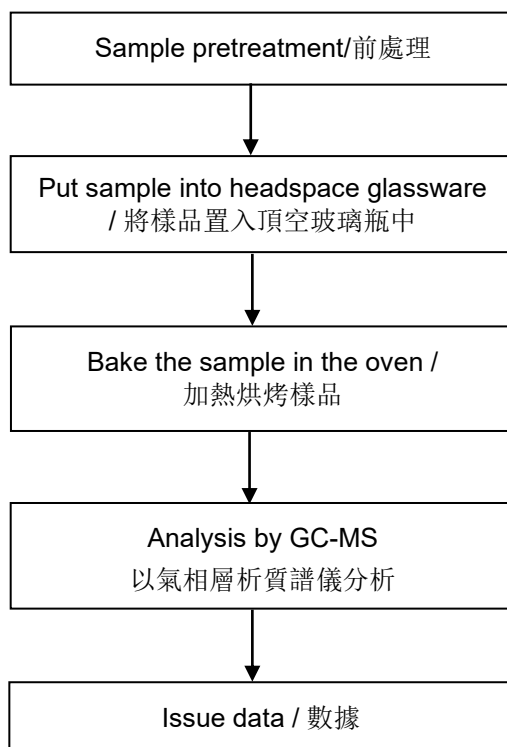
