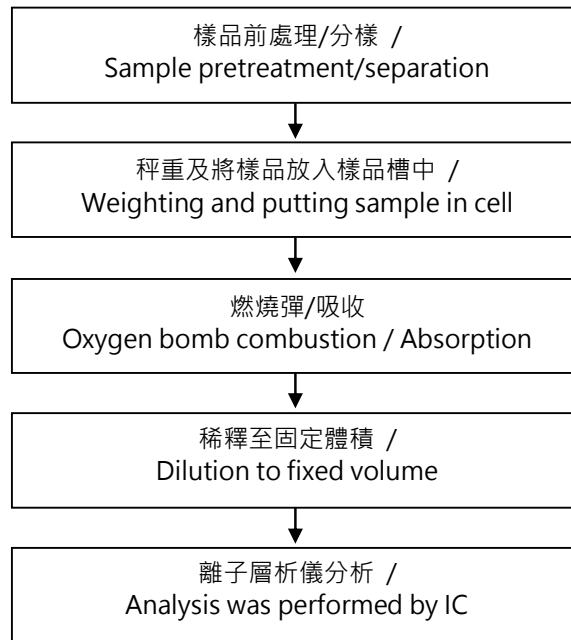

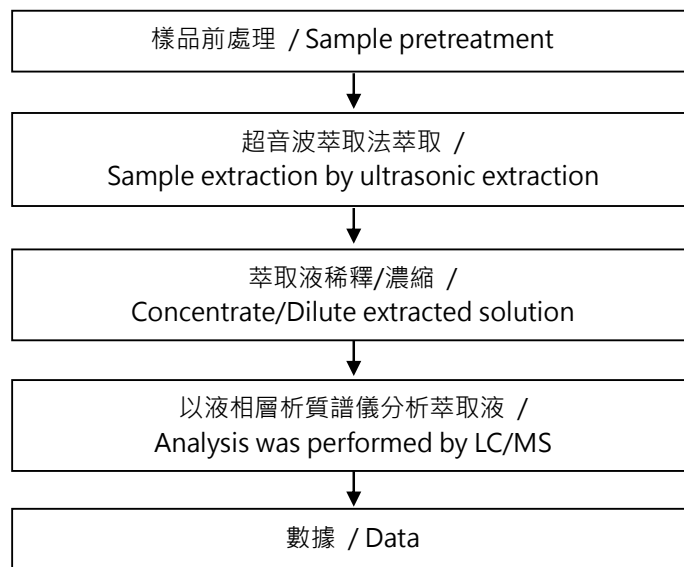

### 鹵素分析流程圖 / Analytical flow chart - Halogen



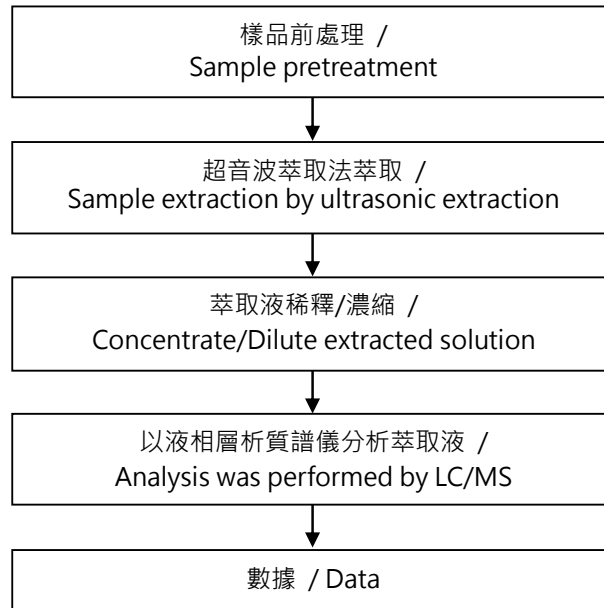

### 全氟辛酸/全氟辛烷磺酸分析流程圖 / Analytical flow chart - PFOA/PFOS



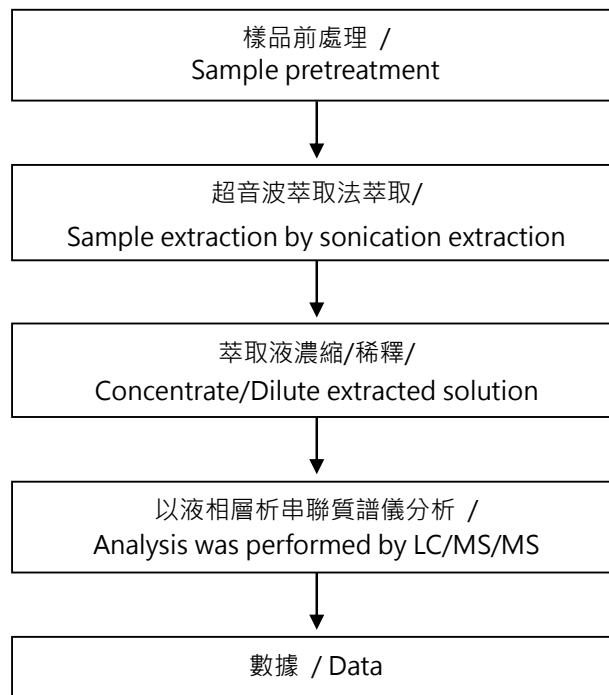

## 雙酚A分析流程圖 / Analytical flow chart - Bisphenol A



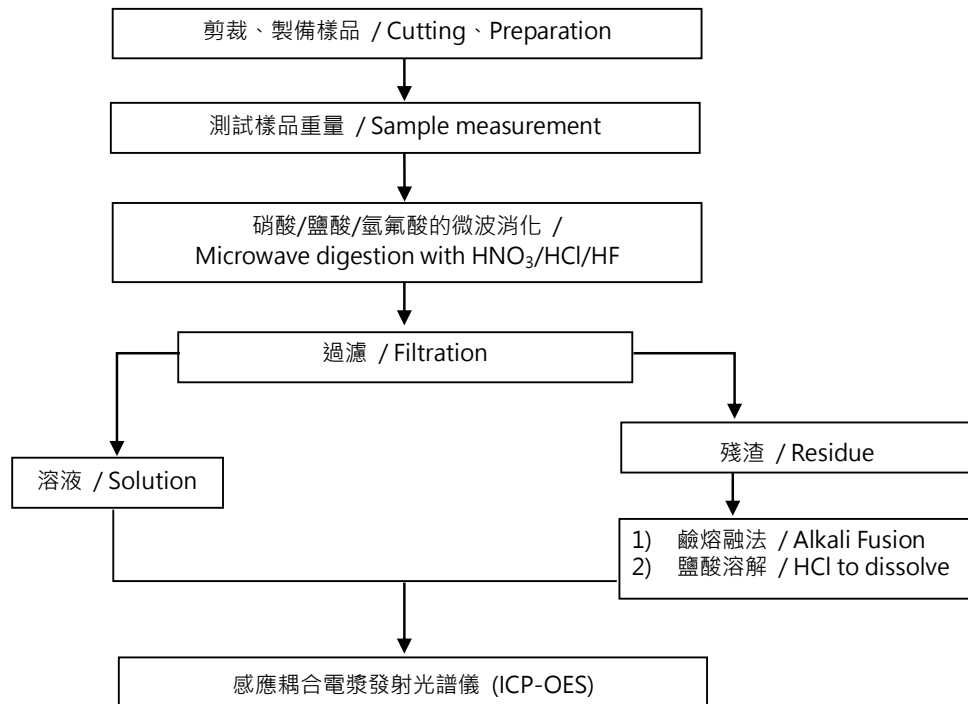

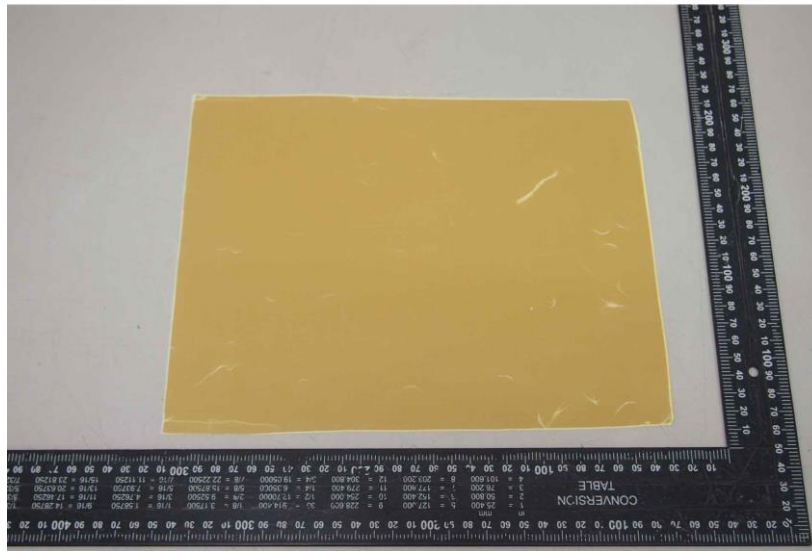
